This release & indemnity continues forever and binds my heirs, executors, personal representatives & assigns.

I acknowledge that events include the real risk of serious injury, or risk of death from various causes including, but not limited to over-exertion, equipment failure, dehydration, accidents with or without other competitors, spectators & road users (including all types of motor vehicles), water craft and/or sea creatures, & weather conditions.
